### Community Grant Guidelines

#### WHO CAN APPLY

A non-profit is eligible to apply if it serves the North Shore community, including West Vancouver, and is a <https://www.canada.ca/en/services/taxes/charities.html> registered charity or qualified donee with the Canada Revenue Agency (CRA).

#### ELIGIBILITY

Community Grants aim to support connection and belonging for the North Shore community and will support a wide range of organizational needs. Organizations must have submitted a final report for previous WVF grants before submitting a new application.

Eligible initiatives:

- Must be charitable in nature;
- Fall within the Impact Areas as listed on the application;
- Must be for the benefit of the North Shore community including West Vancouver;
- Improve connection and belonging for the North Shore community.

The following initiatives are ineligible:

- Deficit reduction (e.g. debts or loans);
- Building an endowment or general fundraising;
- Sponsorships;
- Primarily benefitting individuals (such as scholarships);
- Expenses incurred before the date of grant approval;
- Initiatives without specific benefit to West Vancouver;
- Religious activities or services that focus on only one spiritual tradition;
- Political activity that is prohibited by the Canada Revenue Agency;
- Current curricula for schools.

#### GRANT ASSESSMENT CRITERIA

Each application will be evaluated considering how the applicant demonstrates:

- Connection and belonging incorporated into the project or plan;
- Project clarity/quality of idea;

- Potential for impact and benefit to the North Shore community including West Vancouver;
- How well it serves vulnerable or racialized populations;
- Removing barriers so that everyone can participate / addressing diversity, inclusion, and Reconciliation;
- Appropriate partnerships and collaboration;
- A plan for evaluation and ongoing learning;
- A reasonable budget and timeframe.

### WHAT ARE THE REPORTING REQUIREMENTS?

The West Vancouver Foundation values innovation, experimentation and curiosity. We also place a high value on sharing what we learn openly and honestly, and we want our grantees to do the same. You will be asked to complete and submit a Checklist and Impact Form by the end of the granting year.

### WHAT HAPPENS AFTER I SUBMIT MY APPLICATION?

- Staff may contact you to discuss your application or gather more information.
- The Grants Committee will review and discuss the applications and make their recommendations to the Board of Directors.
- By the end of March 2022, you will receive an email notifying you if your grant request was approved or denied.
